 - a. Seismic zones: Earthquake Zone 3 with soil class C
 - b. Snow Loading: Maximum ground snow load 1.5kPa to AS/NZS 1170.3:2003
 - c. Wind zones: Up to and including high
 - d. Climate zones: Up to and including 3
 - e. Roofing finish: ColorCote ZR8 (excludes sea spray zones and geothermal hot spots)
 - f. Corrosion zone: Up to and including category C to NZS 3604:2011 except where adverse microclimatic factors (e.g. geothermal)
